

**SUMMER VILLAGE OF PARKLAND BEACH  
BY-LAW 2007-05**

A BY-LAW OF THE SUMMER VILLAGE OF PARKLAND BEACH IN THE PROVINCE OF ALBERTA, TO PROHIBIT THE DISCHARGING OF ANY AND ALL GUNS OR FIREARMS WITHIN THE BOUNDARIES OF THE SUMMER VILLAGE OF PARKLAND BEACH.

WHEREAS, pursuant to the provisions of the Municipal Government Act, 2000 and amendments thereto, a Council is empowered to prohibit the discharge of guns or other firearms within the municipality.

NOW THEREFORE the Council of the Summer Village of Parkland Beach duly assembled, enacts as follows:

1. No guns, firearms or other devices that propel a projectile shall be discharged by any person, except those referred to in Section 3 below, within the boundaries of the Summer Village of Parkland Beach.
2. Any person who contravenes any provision of this By-Law is guilty of an offense and is liable on summary conviction to a fine of not less than \$100.00 and not more than \$2500.00 exclusive of costs, and in the case of non-payment of the fine and costs so imposed for any breach shall be liable to imprisonment for a period not exceeding 60 days or both unless the fine and costs, including the costs of committal are sooner paid.
3. This By-Law does not apply to:
  - (a) the discharge of guns or firearms at a site or place where problem wildlife are present and being hunted by a person or persons under the authority of a license issued for such purposes by the Department of Sustainable Resource Development, of the Province of Alberta; and
  - (b) members of the Royal Canadian Mounted Police, who, during the execution of their duties may discharge firearms as they may deem necessary.
